1. **PAYMENTS.** The undersigned Customer hereby makes application for water, sanitary sewer, and sanitation service to be furnished by the City of Tahoka and agrees to take and use same, and pay for all water, sanitary sewer and sanitation service supplied to or for said premises, at the rate now fixed or which may be hereafter fixed by the City Council of the City of Tahoka, Texas as bills are rendered therefor, and for water as measured by the meter, for sanitary sewer and sanitation service as the rate set; and Customer hereby expressly agrees to and this application is made subject to, all and singular, the terms and provisions of the ordinances, resolutions and motions passed by the City Council of the City of Tahoka, Texas, and all rules and regulations fixed and prescribed by the City Council for the management, operation and protection of the Tahoka Public Water System, Sanitary Sewer System, and Sanitation Service thereof.

The undersigned Customer hereby agrees to be held responsible for the payment of all bills rendered for water, sanitary sewer and sanitation service at the listed premiums until written notice is given by the Customer to the City of Tahoka for the cancellation of the contract; subscriber expressly agrees that in the event default is made in the payment of any bill for water, sanitary sewer or sanitation service, said services may be discontinued without notice at the option of the City of Tahoka, This application to become a contract only upon the acceptance of the same by the City of Tahoka.

The applicant shall provide a deposit in the amount specified by the City of Tahoka before service is provided. In the event timely payments are not made, the City of Tahoka may elect to terminate service and apply all deposits to the final bill. In the event that the account is terminated, any excess deposit amounts shall become the property of the City of Tahoka and shall be deposited into the General Fund of
